This authorization and indemnity is in addition to, and in no way limited or restricts, any rights which People's Securities may have under any other agreement or agreements between People's Securities the undersigned, or any of them, now existing or hereafter entered into, and is binding on the undersigned and their legal representatives, successors and assigns. This authorization and indemnity is also a continuing one and shall remain in full force and effect until revoked by a written notice, addressed to People's Securities and delivered to People's Securities at the address set forth above, signed by and _____ Partners. No such revocation shall affect any liability arising out of any transaction initiated prior to such revocation.

The undersigned, jointly and severally agree to indemnify and hold People's Securities harmless from any to pay People's Securities promptly on any debit balance in said account.
